At the request of Sweetgrass First Nation, we have reviewed the Schedules of Salaries, Honoraria, Travel Expenses and Other Remuneration (as outlined in Section 7.3 of the Year End Reporting Handbook for fiscal year 2013 - 2014 from Aboriginal Affairs and Northern Development Canada) for the year ended March 31, 2014.
