## REVIEW ENGAGEMENT REPORT

To the Minister of Aboriginal Affairs and Northern Development Canada:

At the request of Sweetgrass First Nation, we have reviewed the Schedules of Salaries, Honoraria, Travel Expenses and Other Remuneration of Elected Officials (as outlined in Section 7.3 of the Year End Reporting Handbook for fiscal year 2014 - 2015 from Aboriginal Affairs and Northern Development Canada) for the year ended March 31, 2015. Our review was made in accordance with Canadian generally accepted standards for review engagements and accordingly consisted primarily of enquiry, analytical procedures and discussion related to information supplied to us by the First Nation.

A review does not constitute an audit and consequently we do not express an opinion on the Schedule of Salaries, Honoraria, Travel Expenses and Other Remuneration of Elected Officials.

Based on our review, nothing has come to our attention that causes us to believe that this schedule, is not, in all material respects, in accordance with Section 7.3 of the Year End Reporting Handbook referred to above.


