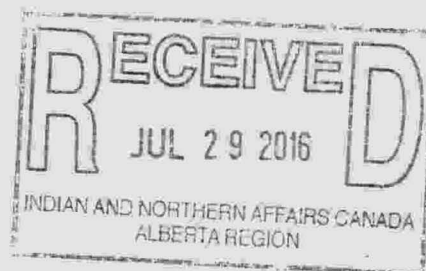

To the Chief and Council Sucker Creek First Nation #150A


