## REVIEW ENGAGEMENT REPORT

To the Members of New Westminster Indian Band,

At the request of the New Westminster Indian Band, we have reviewed Annex B – Schedule of Remuneration and Expenses – Chiefs and Councillors for the year ended March 31, 2014, pursuant with the requirements of the Department of Aboriginal Affairs and Northern Development Canada Year End Reporting Handbook for Funding Agreements, covering 2013-2014. Our review was made in accordance with Canadian generally accepted standards for review engagements and accordingly consisted primarily of enquiry, analytical procedures and discussion related to information supplied to us by the First Nation.

A review does not constitute an audit and consequently we do not express an audit opinion on this Schedule of Remuneration and Expenses.

The Band pays for numerous expenses in cash, the completeness and classification of which is not susceptible of satisfactory review verification. Accordingly, our verification of these expenses was limited to the amounts recorded in the records of the Band and we were not able to determine whether any adjustments might be necessary.

Based on our review, except for the effects of such adjustments, if any, as might have been determined to be necessary had we been able to examine evidence regarding cash expenditures, as described in the preceding paragraph, the Schedule of Remuneration and Expenses present fairly, in all material respects, in accordance with the requirements of the Department of Aboriginal Affairs and Northern Development Canada Year End Reporting Handbook for Funding Agreements covering 2013-2014.
